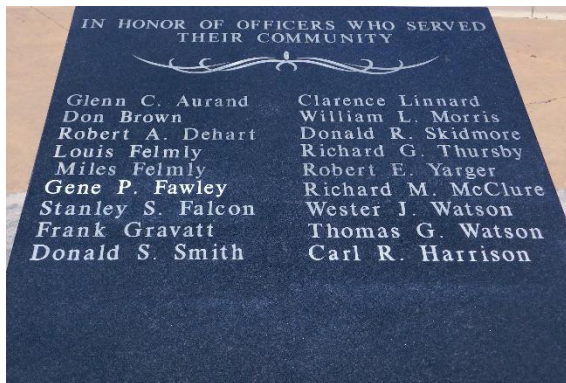

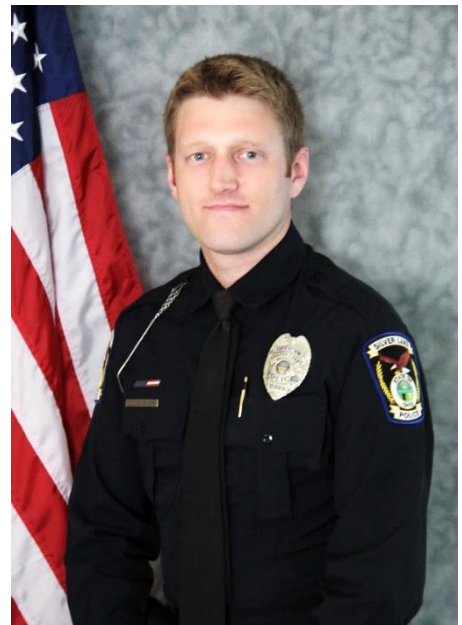


SILVER LAKE POLICE OFFICERS

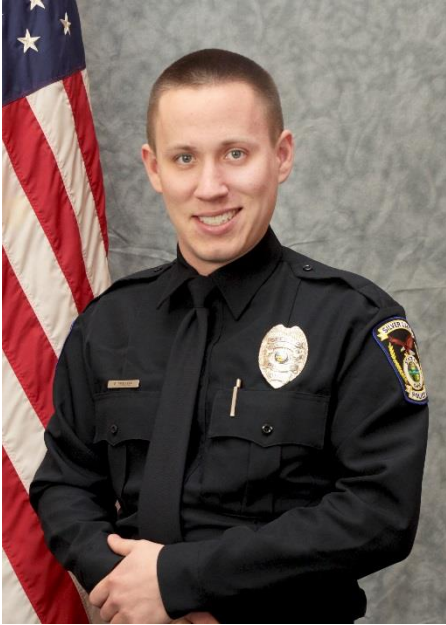

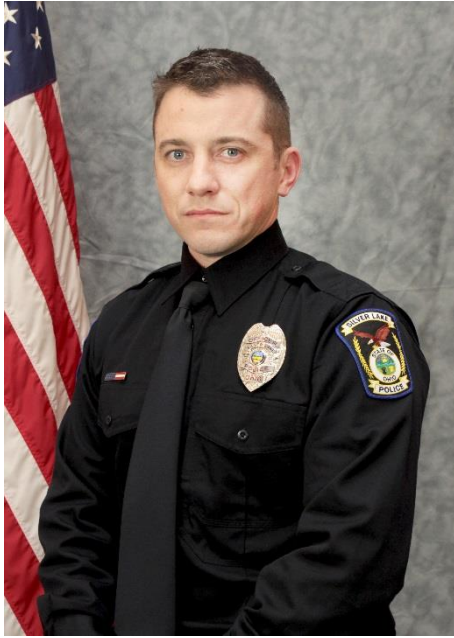
