For Healthier Waterways Remember S.A.L.T this winter:



Salt

Not all road salt is created equal; some won't work below a specific temperature. Check what you have and temperatures before spreading.

Amount

1 mug of salt can cover 250 sqft or 10 sidewalk squares.



Location

Apply salt to paved surfaces and never in gardens or on a storm drain.



Timing

Salt works best when applied before snow or after shoveling.

Plan ahead for the 2024 Rain Barrel Workshop

Following tremendous turnout at the 2023 event, the Watershed Committee is planning another rain barrel workshop on April 13 at the Service Department Garage.

After this year, the workshop will be held every other year.

The village intends to purchase 55-gallon rain barrels and diverter kits and make them available to residents at cost. Pricing is estimated to be approximately \$70-75 per rain barrel, depending on volume and shipping.

Silver Lake Utility Bill Direct Payment Program (ACH) ~ No check writing ~ No postage ~ No late fees ~ No hassles

- Your water/sewer utility bill will be automatically deducted directly from your bank account in cooperation with your bank.
- Automated Clearing House (ACH) is a safe, reliable, and no cost way to pay your bill.
- The utility bill amount is withdrawn from your account on the 20th of each month or the next business day if it falls on a weekend/holiday.
- Utility customers will continue to receive a copy of their utility bill each month.
- You may stop ACH at any time by submitting written notice to the Silver Lake Utility Department.

If you are interested in the direct payment plan for your Silver Lake water and sewer bill, the application can be obtained online at villageofsilverlake.com and then returned to Village Hall.

If you are already enrolled in ACH, you do NOT need to fill this application out again.

I hereby authorize the Village of Silver Lake Utility Department to automatically deduct the monthly utility bill electronically for the service address using the bank account provided above. I have submitted a voided check or a voided savings deposit slip from the account to assure correct bank information. Important Notice: Your next utility bill will not be automatically deducted from your bank account. We must do a pre-note with your bank account in the *first month*. This is a procedure to determine the direct payment is set up properly. Your direct payment will begin the month following your pre-note. This pre-note is for your protection.
