#### Winterizing Tips

Do you have a water meter that is susceptible to freezing? Is it in an unheated part of your home, such as a garage or crawl space? If so, you need to take some precautions during a cold snap, such as temporarily heating this area or letting the water run a little during the night. This is also a good time to double check that all outside spigots have been shut off for the winter.

#### **Snow Reminders**

Residents are required to keep sidewalks free of snow and ice. If you have a fire hydrant in front of your house, clear the snow away so firefighters can locate it in an emergency.

Parking bans go into effect when snow fall reaches two inches or more in a 24-hour period.

Village ordinances prohibit blowing snow into the streets when cleaning driveways and sidewalks.

Always pile snow to the right of your driveway when shoveling. This will minimize the amount of snow pushed back in by the plow trucks as they clear the streets.

#### News from SLPD Jamie Norris, Chief of Police

We receive periodic notifications of vehicles running through red lights at the intersection of Graham and Dover/N. Dover Rd. The Police Department routinely patrols and enforces violations associated with the intersection. There were 196 traffic stops in 2023 for red-light violations for the Graham and Dover area. We recorded two traffic accidents for the year at the intersection and neither of them were the result of a red-light violation. We continue to strive to make improvements and have most recently adjusted the timing of the lights in an attempt to address some of the safety issues in the area. We still maintain that every motor vehicle operator and pedestrian should approach every intersection with extreme caution.

#### Important Note from the Shade Tree Commission

Prune your oak trees now before winter ends! Oak wilt is most active



from April to July, so please avoid pruning oak trees between April 1 and November 15. Only work with TCIA accredited tree companies or ISA Certified Arborists.

Silver Lake Utility Bill Direct Payment Program (ACH) ~ No check writing ~ No postage ~ No late fees ~ No hassles

- Your water/sewer utility bill will be automatically deducted directly from your bank account in cooperation with your bank.
- Automated Clearing House (ACH) is a safe, reliable, and no cost way to pay your bill.
- The utility bill amount is withdrawn from your account on the <u>20<sup>th</sup> of each month</u> or the next business day if it falls on a weekend/holiday.
- Utility customers will continue to receive a copy of their utility bill each month.
- You may stop ACH at any time by submitting written notice to the Silver Lake Utility Department.

If you are interested in the direct payment plan for your Silver Lake water and sewer bill, the application can be obtained online at villageofsilverlake.com and then returned to Village Hall.

If you are already enrolled in ACH, you do NOT need to fill this application out again.

### **Sensible Salting**

To protect our watershed, consider the following salting practices:

- 1) **Shovel snow.** Remove snow and ice quickly. This reduces the amount of salt needed and increases efficiency.
- 2) Follow application instructions. More is not always better. It does not correspond to quicker melting, and excess salt is carried into waterways.
- Reduce chemical application. Only apply salt where it is needed. For example, not every door in your house needs to be accessible. You can also create a path instead of removing all snow.
- 4) Consider temperatures. Most road salts are ineffective below 15 degrees F. Sand can be coupled with salt for better traction but must be swept up after use as sediment is another major stormwater pollutant.
- 5) **Sweep up excess road salt.** If salt remains after ice is gone, sweep it up.
- Pet safety. Sodium chloride, calcium chloride, and magnesium chloride can burn paws. Potassium acetate is safer. Be sure to wash their paws after walking your pets.
